Addressed to the General Public
(Revised 30 June, 2005)

This Agreement constitutes my comprehensive understanding and nature of the potential effects of performing DNA Activations upon myself and their effects upon others.

I have been properly informed that DNA Activations can stimulate physiological, psychological, emotional, and spiritual changes and transitions, both in myself and others. This information has been conveyed to me via any one or any combination of the following: by reading the *book Change Your DNA, Change Your Life!*, by attending a DNA Activation Seminar, from DNA Workshops or Courses, DNA educational handouts and Kits, or verbally.
